In terms of Regulation 30 read with Schedule III to the SEBI Listing Regulations, we wish to inform you that the Nomination and Remuneration Committee vide resolution passed by circulation on July 31, 2024 i.e. today, considered and approved the allotment of **29,285** equity shares of face value of ₹2/- each towards the exercise of vested Employee Stock Options under Refex Employee Stock Option Scheme 2021 ("**ESOP 2021**"), to the eligible grantees, pursuant to exercise of options granted thereunder.

The equity shares so allotted under ESOP 2021, shall rank pari-passu with the existing equity shares of the Company in all respects. Consequent to the aforesaid allotment, the paid-up share capital of the Company will accordingly increase from ₹24,13,62,780/- (12,06,81,390 equity shares of ₹2/- each) to ₹24,14,21,350/- (12,07,10,675 equity shares of ₹2/- each).
